

House rules Mini camping De Witte Baai

In order to make your stay and that of others as pleasant as possible, we use the following house rules during your stay.

Rest on the campsite

1. Between 11 pm and 8 am. it is quiet at the campsite.
2. To maintain peace at our campsite and in the immediate vicinity it is not allowed to cause noise nuisance. Do you also take your neighbours into account if you are still sitting outside in the evening?
3. We take Sunday rest into account. This means among other things that the reception is closed and that no activities are organized. We also try to minimize arrivals on Sunday.

Liability

4. Do not leave your belongings unattended on the campsite and in your car. Mini-camping De Witte Baai is not liable for loss, damage or theft of your property.
5. During your stay you use properties of Mini-camping De Witte Baai treat these properties as if they were your own belongings.
6. Mini-camping De Witte Baai cannot be held liable for fire, loss or damage caused by third parties.
7. The use of the playground equipment at the campsite is at your own risk.

Respect

8. We treat each other respectfully at Mini-camping De Witte Baai. Aggression, verbal or non-verbal will not be tolerated.
9. In order to maintain a good atmosphere and peace on the campsite everyone is expected to behave in such a way that no nuisance is caused to another in any way.

Camping site

10. In consultation with the holiday maker, a pitch is determined by the manager and, if desired, he / she gives instructions regarding the placement of the camping accommodation.
11. Subletting the camping accommodation is not allowed.
12. The use of agricultural plastic or anti-root cloth outside the grass blocks is not permitted to prevent the grass from dying.
13. Please place caravan (incl. awning), camper or folding trailer as much as possible on the paved surface of the camping pitch.
14. Barbecuing is allowed, but be careful not to burn the grass (!).

Chalet

15. Arrival from 3 pm and departure before 10 am.
16. Leave chalets wipe clean on departure, gather the bedding from the beds (excluding underpad and extra pillowcase) and empty the refrigerator, freezer and trash cans.
17. Smoking is not allowed in the chalets.
18. Pets are not allowed in our chalets.

(Pre- and post-) Seasonal pitch

19. In order to set up the caravan at the beginning of the (pre) season as smoothly as possible, it is appreciated that the arrival date is communicated in advance.
20. The pre- and post-season pitches and seasonal pitches include 2 people. Extra persons can stay overnight at the rate of overnight for extra persons (see our website). The extra nights can be settled after the rental period.

Reception

21. The opening hours of the reception are indicated at the entrance of the reception, only for urgent matters or emergencies you can go to the house outside these times unless otherwise indicated at the reception.
22. Upon arrival at the campsite everyone is required to first report to the reception to check in.

Pets

23. After permission from the manager and after payment of the rate for pets, it is allowed to keep maximum of 2 pets on one camping pitch. Make sure that the pets do not disturb other campers.
24. Campers' dogs must be kept on a lead at all times.
25. Dogs must be walked outside the camping site, along the public road. It is not allowed to walk the dog on the maintenance strip on the outside of the campsite, on the playing field or on the arable land around the campsite.
26. To avoid inconvenience to the environment it is desirable to use poop bags when walking the dog.
27. Dogs are not allowed in our chalets.

Car

28. We are a car-free campsite. On arrival and departure the car may be temporarily parked at the camping pitch / chalet for loading or unloading.
29. Maximum speed at the campsite is at walking pace (10 kilometers per hour)!
30. When the parking lot at the campsite is full the driveway to the farm can be used as an overflow area.

Waste

31. Deposit your household waste in there for designated containers in the parking lot and not in the waste bins near the bathroom.
32. It is not allowed to discharge waste water outside the designated drain.

Sanitary and general facilities

33. To maintain hygiene in the sanitary buildings leave the building tidy after use.
34. Young children must use the sanitary buildings under the supervision of an adult.
35. Emptying toilet buckets, chemical toilets and waste water should be done in the chemical disposal site on the side of the toilet building.
36. It is not allowed to flush cloths, tampons and other synthetic material in the toilet.
37. The washing-up area on the side of the toilet block is not intended for washing clothes. For hand washing clothes you can use the sink in the space near the washing machine and dryer.
38. It is forbidden to smoke in all public buildings.

General

39. Day guests are welcome, but must be reported and settled at the end of the holiday maker's stay.
40. The campfire is lit only on the initiative of the manager or in consultation with the manager at the common fire pit. It is not allowed to make a fire in other places on the campsite.
41. The delivery of goods on the campsite must always be reported in advance to the reception.
42. Swimming pools, inflatable or with a hard wall, the edge of which is higher than 30 cm are **prohibited**.
43. Placing a children's pool (inflatable pool of which the edge is a maximum of 30 cm) on the camping pitch rented by the holiday maker is permitted, provided that an adult is present to supervise anyone who is in or around the pool. It must be clear to the holiday maker that he/she is at all times responsible for everyone in or around the children's pool for everything that happens in the pool in his/her presence or absence. In the evening and at night and when leaving the camping pitch, the holiday maker must remove the water from the swimming pool.
44. There is no fixed limit on the amount of data used from our WiFi network. The administrator can intervene if significantly more data traffic is used than the average.
45. It is not allowed to walk on the maintenance strip on the outside of the campsite or on the arable land around the campsite.
46. It is not allowed to fly with a drone above the campsite or close to the campsite.
47. Complaints etc. must be reported to the manager and will be resolved within reason.
48. In cases where these house rules do not provide, the manager decides.
